If the inmate is housed in the Medical Unit, visit approval will be granted by Medical Staff/Shift Lieutenant on a case by case basis. Visit times will be the same as A-Pod.

PLEASE BE HERE 30 MINUTES BEFORE VISIT TIME FOR PROCESSING

- Inmate Commissary Accounts: money received must be in the form of a money order and sent through the mail.
- The money order must be payable to the inmate.

- The following are the methods for depositing money on Inmate Commissary Accounts:
 1. Lobby Kiosk deposits using cash.

 3. Toll free phone deposits 1-866-345-1884
 4. Money received must be in the form of a money order and sent through the mail. The money order must be payable to the inmate. This facility will accept only a bank check or money order by mail for deposit in an inmate's account. The inmate will be given a receipt for the deposit.

- A former inmate cannot visit a current resident of the jail for at least twelve months from their last incarceration. After twelve months, permission to visit must be approved in writing by the Jail Administrator or designee. Any person with pending criminal charges or under the supervision of Probation and Parole will be denied visiting privileges. Administration will review past charges and history prior to making a decision.
- Incoming calls are prohibited. In the event of an emergency, the information will be verified by a staff member. Upon verification, the message will be given to the inmate.
- Special or extended visits may be offered in emergency situations to include but not limited to serious illness, death in the family or transfer out of state. Duration of the special or extended visit will be decided on a case by case basis.
- Children/minors must have a parent or legal guardian with them to visit. Incarcerated parents must have the other parent or legal guardian with them to visit. Documentation must be provided to show the guardianship. (temporary or permanent).
